TD Rally[®] Eligibility

All competitors must be registered with TD Rally[®] prior to competing at any sanctioned TD Rally[®] trial. To register, contact the office or go to the website www.talkingdogsrally.co.uk and download the registration form and send it with payment to the TD Rally[®] office.

Everyone over the age of 7 years (children under 16 years old must be accompanied by a parent or guardian) on the date of the trial is eligible to compete once registered with TD Rally[®].

All breeds of dogs, crosses and mixed of breeds over 6 months old on the date of the trial can compete. Health and behaviour may exclude dogs from competing, but breed type does not.

Competing Levels

Puppy is for dogs aged 6-18 months old on the date of the trial.

Level 1 is for dogs 1 year and older on the date of the trial.

Veteran Level 1 is for dogs over 7 years on the date of the trial.

Pre-Level 2 and Level 2 is for dogs 1 year and older on the date of the trial. This level is for handlers who have already won a TD Rally[®] Level 1 Title or Championship and who are working towards their Level 2 Title.

Veteran Pre-Level 2 and Veteran Level 2 is for dogs 7 years and older on the date of the trial. This level is for handlers who have already won a TD Rally[®] Level 1 Title or Championship and who are working towards their Veteran Level 2 Title.

Level 3 is for dogs 1 year and older on the date of the trial. This level is for handlers who have already won a TD Rally Level 2 Title or Championship and who are working towards their Level 3 Title.

Veteran Level 3 is for dogs 7 years and older on the date of the trial. This level is for handlers who have already won a TD Rally[®] Level 2 title or championship.

Level 3+ is for teams who have already won a TD Rally Level 3 Title or Championship.

TRIAL RULES

PLEASE READ CAREFULLY. YOU AGREE TO ABIDE BY THE TRIAL RULES WHEN ENTERING THE TRIAL.

1. Each team, a team consisting of one dog and one handler, must hold a valid TD Rally[®] registration. Teams with disabilities must have submitted a disability modification form to the Talking Dogs Rally[®] office prior to the trial or along with their trial application form. Disability modification forms will not be accepted on the day of the trial.
2. No unregistered substitutions for handler or dog are permitted.
3. The trial host reserves the right to refuse any entry for any reason.
4. Refunds cannot be guaranteed for entries withdrawn or dismissed for any reason but may be given depending on circumstances. No refunds are given for withdrawn entries after the closing date.
5. Returned cheques do not constitute a valid entry.
6. If the trial host cancels the trial, the trial host will refund all trial fees in full to registered competitors within 14 days of the trial date. If Talking Dogs Rally[®] cancels the trial, the trial host will refund all trial fees in full to registered competitors within 14 days of the trial date.
7. The judge's decision is final.
8. Your team may not compete if your bitch comes into season immediately prior to or during the trial.
9. Do not bring your dog to the trial if she/he is ill or has been infected or in contact with another dog infected with a contagious disease in the last 21 days prior to the trial. If your pet is ill or suffers an injury during the trial, please notify the trial secretary.
10. Competing in Talking Dogs Rally is a physical activity and as such handlers are reminded to work with due care and attention to their own safety and that of others. Handlers are responsible for the conduct of their dog at all times. Neither Talking Dogs Ltd., Talking Dogs Rally nor the trial host or any person acting on behalf of the Talking Dogs Rally or the trial host accept any liability for any loss, damage, accident, injury or illness to dogs, handlers, spectators or any other persons or property whatsoever.
11. Goods may not be sold at the venue without prior permission.
12. No mating, or sale of dogs is permitted at the venue.
13. Photographs and or recordings may be taken by and on behalf of the trial host for educational and publicity purposes. All other photographs and/or recordings may be taken for personal use only.

14. Please keep all dogs on lead outside the ring.
15. Any person handling their own or any other dog in a harsh manner, will be asked to leave the trial and venue. Any physical disciplining of a dog by a person in or outside the ring or any uncontrolled behaviour of the dog, must be reported to the show secretary with full details presented.
16. All dogs have to be under control at all times. Please respect other handlers and dogs and do not approach / let your dog approach any other dog on or off lead without the consent of the other handler.
17. A judge can dismiss any handler and dog from the ring if the safety or welfare of the dog, the handler or any other person and/or dog is compromised.
18. There will be a designated exercise area. Please be respectful to other dogs and handlers and do not let your dog approach others without their clear consent (regardless of your own dog's size, breed or perceived temperament). Please pick up after your dog and dispose in the designated bins.
19. Please pick up after your dog anywhere at the venue. Please do not allow your dog to wee at the ring fences, gazebos, or equipment. Please do not take your dogs inside the village hall.
20. Dogs in cars on hot days. Please take every precaution to keep your dog(s) comfortable and cool in your vehicles as well as during a trial with providing water and shading your car. It is the owner's/handler's responsibility to take the right precaution to prevent distress and/or overheating.
21. By entering this trial, handlers acknowledge and agree to abide by the trial rules as laid out by the trial host as well as Talking Dogs Rally[®].
